- ◆ For the purpose of these Terms & Conditions of Consignment to Sale, Sales Management will refer to Red Cow Relocators.
- ◆ A complete registration paper for each animal will be supplied to the Sales Management prior to the sale.
- ◆ Seller is responsible for the transfer of the animal to the buyer through RedsPro unless otherwise arranged with Sales Management. Sale Management will provide all buyer information upon sufficient settlement by the buyer .
- ◆ All animals must be eligible for interstate shipment.
- ◆ All health certificates are to be turned into the Sales Management prior to the sale.
- ◆ All live and frozen lots catalogued and scratched prior to arrival to the sale will forfeit the entry fee of the said lot as well as any prepaid stall fees or expenses for that animal.
- ◆ All live animal lots scratched after arrival to the sale will forfeit the entry fee, any prepaid stall fees or expenses as well as being assessed or invoiced any expenses incurred by the sale for that animal such as but not limited to stall fees, feed, or bedding.
- ◆ All live and frozen lots which no sale and/or bought back through the ring, will be assessed full sale expenses based on the dollar amount of the last bid in the sale ring.
- ◆ All live animals will sell with a guarantee by the seller as outlined in the RAAA Code of Ethical Sale Practices. All warranties, guarantees and refunds on any live animals not meeting the standards of the RAAA Code of Ethical Sale Practices shall be made by the seller to the buyer upon proof of cattle not meeting their representations in the sale.
- ◆ All persons who attend the sale do so at their own risk. The Sales Management or auction facility assumes no liability for any accidents that may occur. The Sales Management or auction facility does not assume any liability for loss or injury to livestock due to theft, mysterious disappearance, sickness, improper handling or Act of God.
- ◆ Sales management and its representatives act only as an agent between buyers and sellers.
- ◆ Settlements of consigned lots to the seller for this sale will be made within 15 business days of when the buyer makes sufficient settlement of the purchase.
